Four years have passed now since the start of the full-scale invasion. Its prolonged nature continues to shape the lives of millions of Ukrainian families. Over this extended period of conflict, almost 8 million Ukrainians have left the country. Most of them are mothers and children. What began as an emergency evacuation has, for many, turned into long-term or even permanent separation. Many children have had little or no contact at all with their fathers in those 4 years – a long time in a child's life. Others have attempted to sustain co-parenting over several years despite separation across international borders and an active conflict zone.

What challenges do these parents face? Both from a practical, emotional and legal point of view? How can parents settle their disputes regarding contact, country of residence, the involvement of grandparents and the extended family in the upbringing of children? How can mediation assist parents in resolving these issues amicably and what are the special features of mediating these cases having regard to the particular context and the specific challenges posed by the war? ®

**To find answers** to these questions we would like to **invite Ukrainian family mediators**, residing in the Ukraine and those residing abroad, to participate in the ***Cross-border Family Mediation Training for Ukrainian Mediators***. The 50-hour training course will also cover many other aspects of family mediation between parents separated by a border. It aims to qualify Ukrainian family mediators to mediate cross-border family disputes, including international child abduction, child access and custody cases. The course will cover relevant legal aspects of international family conflicts, including differences in national family law and the 1980 and 1996 Hague Conventions as well as the Voice of the Child in child abduction proceedings and mediation. Participants will get acquainted with the tools and methodologies of mediation in international family disputes with the aim of protecting the best interests of the child. Practical role plays form an integral part of the training.

This MiKK CBFM® Training has been specially adapted to equip mediators with the knowledge and skills to help resolve cross-border family disputes between Ukrainian parents, taking into account the specific challenges presented by wartime. Other topics featured in this training include: Parental Alienation and the Specifics of Trauma-informed Mediation.

**MiKK - International Mediation Center for Family Conflicts and Child Abduction** is the leading international training provider in the field of international family mediation. MiKK has been conducting cross-border family mediation trainings and workshops internationally for close to 25 years now. The standardised Cross-border Family Mediation (CBFM®) Training concept was originally developed by MiKK in the EU co-funded Training in International Family Mediation (TIM) project in 2010. Over the past 16 years, MiKK has continuously adapted, improved and updated its CBFM® Training to keep abreast of any changes in the mediation and legal environments and to take into account feedback from international participants. So far, over 500 mediators from more than 50 countries have successfully completed the MiKK CBFM® Training which is run in different countries (Germany, France, Spain, Japan, Singapore) and in different languages: in English, French, German, Spanish and also in Ukrainian/English. For this Zoom Training for Ukrainian mediators, which was piloted in 2023, the MiKK CBFM® Training concept was modified in parts to allow the integration of specialist modules conducted by expert trainers from the Ukrainian Academy of Mediation (UAM), the Ukrainian Central Authority, the Mediation School and other Ukrainian expert speakers as to address the problems and particular challenges arising for families in times of war.

#### TRAINERS:

A team of international trainers from MiKK, UAM, Mediation School and experienced independent trainers, as well as representatives of the judiciary and Central Authorities all of whom are experts in their fields, will conduct this interactive training course, which aims to equip family mediators with the necessary knowledge, skills and tools to mediate complex international family disputes with a particular focus on cross-border disputes involving Ukrainian families.

## TERMS OF PARTICIPATION, FEES & PREPARATION

### General

- This training is open to certified Ukrainian family mediators only, regardless of their country of residence.
- The number of places is limited. Please apply as soon as possible. If the number of applications exceeds the maximum number of participants, preference will be given to practising family mediators.
- Registration for the training will be open until **1st March 2026** (participants will then be informed whether or not they have been selected to participate in the training).

### Training Course Fee

- There is no training fee payable for participating in this training, however in return for participating, mediators are asked to agree to making themselves available for conducting two pro-bono mediations in an international family dispute between Ukrainian parents. To implement this obligation, mediators are kindly requested to register on the mediation-help.com platform [www.mediation-help.com](http://www.mediation-help.com). After successful conclusion of the CBFM® Training for Ukrainian Mediators, mediators are obliged to include their offer to conduct 2 free-of-charge mediations to their Mediation Help profile (as was agreed as a condition for participating in the training).

### Preparation for the Training:

- Please allow at least 4 hours to prepare before the first training session on Day 1. Preparation will involve: familiarising yourself with the applicable international legal instruments, answering some questions on National Family Law (Ukraine and other countries) and watching a 35-minute film (online). All of this information will be sent to participants in advance. The total time of preparation, homework and reading for **both modules** amounts to **10 hours**.

### Certificate & Listing:

- Active participation in at least 90% of the training is required in order to be selected and to receive a certificate.
- In addition to being listed on the Mediation Help Platform, each participant who has successfully concluded the training and has fluent English or German will be able to join the **International MiKK Mediators listing free-of-charge for two years (until 2028)**.

### KEY DETAILS OF TRAINING:

**Training Dates:** The training will take place in two parts/modules:  
**9-11 March (3 days) & 16-19 March (4 days) 2026.**

**Times:** Please note that there are shorter training days 11am-3pm (Ukraine time) and longer days 11am-5.30pm on days where there are afternoon role plays, as well as on the last day.

**Format:** Online (via Zoom)

**Training language:** The training language is **English** with **simultaneous translation** into **Ukrainian**; Some training sessions will be conducted **in Ukrainian** (and translated into English). Please note that the **language of the role plays will be Ukrainian** (the role-play sessions will be supported by the Ukrainian trainer team).

**The Training is co-funded by the EU (ACCORD 2 and Consent Projects) and the simultaneous interpretation is funded by the IRZ (German Foundation for International Legal Cooperation) and the German Ministry of Justice.**

## Information on the Trainers



**Ischtar Khalaf-Newsome** is Head of Advisory Services and Co-CEO of MiKK e.V. - International Mediation Centre for Family Conflict and Child Abduction in Berlin. She is a cross-border family mediator, family lawyer and MiKK cross-border family mediation (CBFM®) trainer. Prior to joining MiKK in 2014 she practised family law for nine years with *Dawson Cornwell*, a London based family law firm specialising in international family law and 1980 Hague child abduction cases. Before that, Ischtar worked as a case manager at *reunite International* in London. She holds an MA in Near & Middle Eastern Studies & Islamic Law (SOAS, University of London) and an MA in German & English (Freie Universität, Berlin). Ischtar qualified as a mediator with the Family Mediators Association (FMA, London) and with Inmedio (Multi-Track Peace Mediation, Berlin). She trained in Child Inclusive Mediation (CIM) with the FMA. Ischtar has developed training content and conducted mediation trainings for MiKK and other institutions (ERA, EJTN) and for EU co-financed projects (LEPCA, VOICE, I-CARE) and has co-conceived EU co-financed projects (i.e. AMICABLE, ACCORD). Ischtar has presented on behalf of MiKK at the EU Parliament, JURI Committee; the Experts' Meetings EM I & II (London) and the Malta Process Conference of the Hague Conference on Private International Law (HCCH). She is Co-editor of *Cross-border Family Mediation. International Parental Child Abduction, Custody and Access Cases* (Paul, Kiesewetter, Khalaf-Newsome eds., 3rd expanded edition, Metzner Publishing, 2023) in which she co-wrote the chapter on Mediation in Non-Hague Muslim countries and on the MiKK CBFM® Training. She is the author of the chapter on cross-border family mediation in *Research Handbook on International Child Abduction. 1980 Hague Convention. Edward Elgar Family Law Series*. Co-founder and Honorary Member of the National Association of Mediators of Ukraine, and Chair of the Mediation Committee of the National Bar Association of Ukraine. Co-author of the Law of Ukraine "On Mediation," the Code of Professional Ethics for Mediators, and the Core Principles for Training in Basic and Family Mediation Skills.



**Tetiana Bilyk** - Accredited international mediator (2009 CEDR, UK; 2021 MIKK, Germany), trainer and supervisor of mediators; Chairman of the Board of the NGO "League of Mediators of Ukraine"; Chairman of the Board of the NGO "International Training Center "Mediation School"; Co-founder and Member of the Supervisory Board of the NGO "Association of Family Mediators of Ukraine"; Contact of ISS (International Social Service, General Secretariat, Switzerland) in Ukraine within the framework of cooperation on cross-bordering family mediation. Psychologist, psychotherapist.



**Dr. Lesley Allport** has a long career in mediation spanning the last 26 years. Working initially as a family mediator in the 1980's, she has been involved in developing new areas of practice, particularly in the context of Special Educational Needs and Disability Conciliation. She mediates in workplace disputes, has experience in community mediation and is trained to mediate in cross border family disputes and parental child abduction cases. Lesley began training mediators 18 years ago. She delivers foundation courses in several contexts as well as training for supervisors and mediators working directly with children and general continuing professional development. She has a keen interest in developing professional standards. She is a Board member of the College of Mediators and currently chairs the Professional Standards Committee. She also sits on the editorial board of the new College journal "Mediation: Theory and Practice". Lesley also has an academic interest in mediation. In 2005, she completed a European Masters' Degree in Mediation, as part of which she developed a model of supervision specific to mediation. In 2016, she successfully completed her Ph.D. at the Birmingham Law School where she was examining the comparative growth of mediation, identifying similarities and differences of practice across a number of contexts of mediation delivery. **Lisa Parkinson** is a grandmother in family mediation, as well as in her own family. 45 years ago, she co-founded the first family mediation centre in the UK and a few years later, helped to set up the first national association of family mediators with a Code of Practice and training programme. Lisa drew from her experience in mental health social work and family therapy to develop a family systems approach to mediation with separated couples, parents and carers, rather than settlement-seeking mediation focused on adult negotiations without considering the child's right to be heard. Parental conflict harms children's well-being and development, especially where there is litigation and continuing dispute. Together with five family lawyers in London, Lisa launched a pilot project in 1986 to extend mediation from child-related issues to all issues, including finance and property.

The Family Mediators Association was founded in 1988 (Lisa was appointed director and now a Vice-President), providing cross-disciplinary training in co-mediation on all issues. As a founder member of the European Forum on Family Mediation and World Mediation Forum, Lisa has taken part in conferences and given mediation training in many countries including Argentina, Canada, Finland, France, Germany, Italy, Kazakhstan, Morocco, Portugal, Russia, South Africa, Spain, Switzerland, Turkey, Ukraine and the US. The 4<sup>th</sup> English edition of her book, *Family Mediation*, was published in 2020, with seven editions in other languages. Now retired from mediation practice, Lisa continues to give training mainly in child-inclusive mediation (ChiM – children in mediation), so that children and young people can be offered the opportunity to talk with a ChiM-qualified mediator, if they wish, and have their views and suggestions taken into account by their parents. Arrangements agreed within the family work better and last longer than a court order. In 2022 Lisa was delighted to win the National Mediation Significant Achievement Award.



**Martina Erb-Klünemann** is a German family court judge. She worked as a judge in general civil and criminal law cases at various courts before her appointment as a family judge in 1996. In this capacity she is responsible for international family conflicts pending at her court in Hamm/ North Rhine-Westphalia as a specialized court for a district covering nine million inhabitants. She has extensively published in the field of international family law and acts as an expert for the Hague Conference on Private international law and on the European level.

Martina is a network judge in the European Judicial Network in civil and commercial matters (EJN) and in the International Hague Network of Judges (IHNJ) as well as co-chair of the

Association of International Family Judges (AIFJ). She runs Europe-wide training courses on cross-border family law. For years she is involved in the training in cooperation in civil matters run by the European Judicial Training Network (EJTN). Her main focus is on strengthening children's rights in cross-border proceedings.



**Olha Zozulia** is a lawyer. She is in charge of operations with the international treaties on child protection sphere in the Ministry of Justice of Ukraine.

Her professional skills and knowledge concern the theme of child protection and child abduction, including procedure of mediation in cross-border family disputes, custody issues and scope of the parental responsibility and other legal representatives of the child, applicable law, jurisdiction, procedure of recognition and enforcement.



**Anne-Ruth Moltmann-Willisch**, LL.M.(Mich.); former judge at civil courts of Berlin; judge mediator and coordinator of mediation by judges in civil court proceedings in Berlin (2009-2021); Trainer in mediation for judges in Berlin/Brandenburg and the German Judicial academy; member of the scientific advisory board and teaching qualification at the European University Viadrina Frankfurt/Oder; Freelance mediator and chairman of complaints committees (GEMA and DGPT).

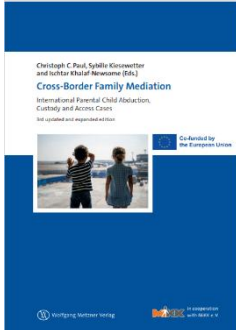
Trained as a mediator and cross-border mediator, she graduated in administration from the Faculty of Administration and Social Sciences at the Warsaw University of Technology (MA).
